Leading by Example: Strategic Sustainability Performance Plans

When signed on October 5, 2009, Executive Order (E.O.) 13514 made reducing greenhouse gas emissions a top priority for the Federal Government. Entitled *Federal Leadership in Environmental, Energy, and Economic Performance*, the executive order establishes an integrated strategy towards sustainability across all modes of operation. The Federal Government will lead by example toward a clean and efficient energy economy.

One requirement within E.O. 13514 is the development and implementation of an agency Strategic Sustainability Performance Plan (SSPP) that prioritizes agency actions based on lifecycle return on investment. Each SSPP is required to identify, among other things, "agency activities, policies, plans, procedures, and practices" as well as "specific agency goals, a schedule, milestones, and approaches for achieving results, and quantifiable metrics" relevant to the implementation of E.O. 13514.

Federal agencies should utilize their Energy Independence and Security Act (EISA) of 2007 Section 142 executable plan annual updates to meet the fleet portion of their SSPP. In addition, agency Annual Fleet Compliance Reports and Annual Office of Management and Budget (OMB) Transportation Scorecards contain a significant amount of information that can be used to populate the fleet portion of an SSPP. Each agency's SSPP will be unique, and the exact timing of

the SSPP submissions is yet to be determined. The Federal Energy Management Program (FEMP) recommends that agencies create the fleet management portion of these plans around January 1 to coincide with developing the EISA Section 142 annual update, the Annual Fleet Compliance Report, and OMB Transportation Scorecards.

Reminder: Annual Fleet Compliance Reports due February 15

Federal agencies are required to provide Congress an annual written compliance report on fleet management for the previous fiscal year. Using data collected at the beginning of each fiscal year in the Federal Automotive Statistical Tool (FAST), each agency must submit an annual report describing its compliance with Federal fleet requirements within the Energy Policy Act (EPAct) of 1992 and 2005 as well as progress made toward the fuel consumption goals outlined in E.O. 13423.

A hard copy of the report must be published on a publicly accessible Web site by February 15 and provided to Congress. Fleet managers must also send the Web site link of their report to the U.S. Department of Energy (DOE) via <u>federal_fleets@ee.doe.gov</u> for publication on the FEMP Web site at <u>www.eere.energy.gov/femp/regulations/fleet_reports.html</u>. This link must be sent to DOE by the **end of February** each year.

Alternative Fuel Finder

The National Renewable Energy Laboratory (NREL) maintains a database of alternative fuel stations nationwide through the DOE Alternative Fuels and Advanced Vehicles Data Center (AFDC). The list below shows new alternative fuel stations added to the database since last publication. *Unless otherwise noted, only open, publicly accessible stations that accept Wright Express are included*.
